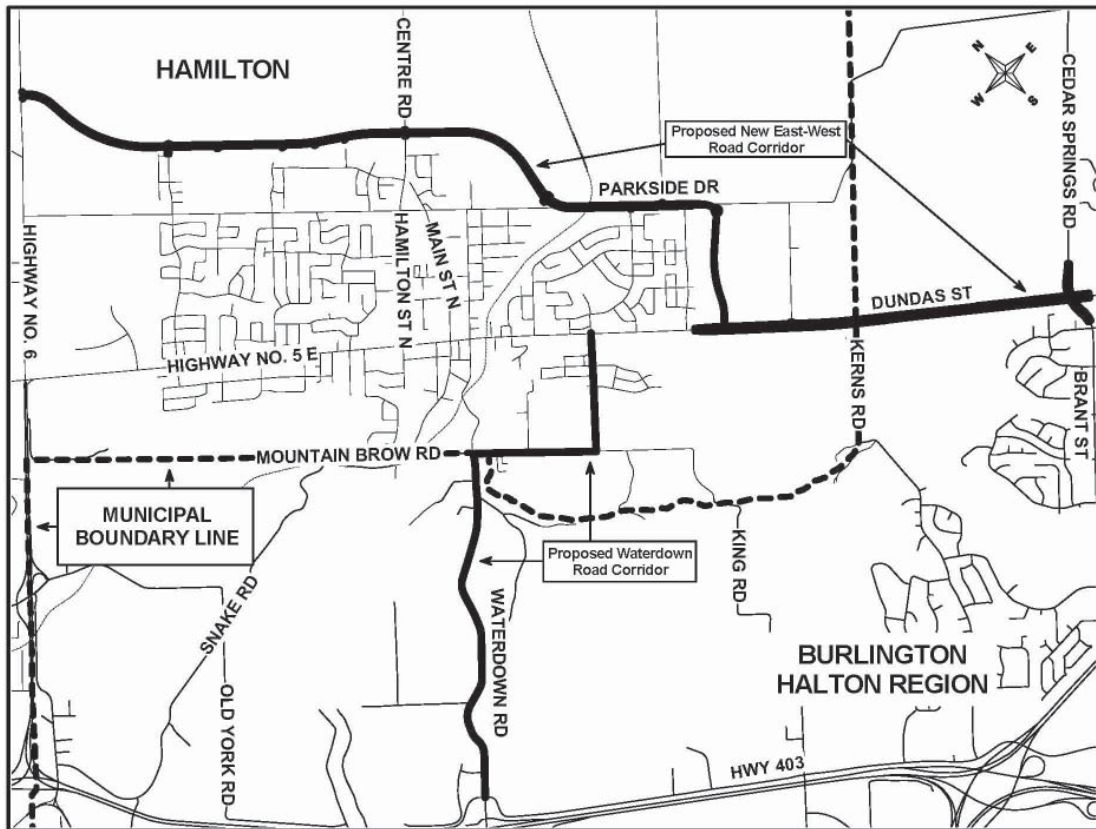


THE STUDY AND PROCESS

The Cities of Hamilton and Burlington and the Region of Halton completed the Waterdown-Aldershot Transportation Master Plan (WATMP) Phase 2 Report in February 2008 to identify a future transportation plan to service future urban development in the Waterdown-Aldershot area. The WATMP recommended increasing transportation capacity through public transit, bicycle routes, transportation demand management and road improvements. Phases 1 and 2 of the Municipal Class Environmental Assessment (EA) process were completed during the WATMP.

Building on the recommendations of the WATMP, Phases 3 & 4 of the EA process were completed for two projects:

- A New East-West Road Corridor (Highway 6 to Brant Street)
- The Waterdown Road Corridor (Craven Avenue to Dundas Street)



Both projects have been carried out in accordance with Schedule C of the Municipal Class EA process (Municipal Engineers Association, October 2000 as amended in 2007 & 2011).

PUBLIC REVIEW PERIOD

A Class EA Environmental Study Report documenting the planning process undertaken and conclusions reached for each of the road projects will be placed on public record for 45 calendar days in accordance with the Municipal Class EA, for each project. **The public review period will begin on June 1, 2012 and end on July 16, 2012.**
