Dear Resident/Property Owner:

Beginning this winter, Halton Region will be rehabilitating wastewater mains, laterals and maintenance holes on Beaver Street, from First Street to 125 metres south of First Street ([see attached map](#)). This work will require significant excavation along the east boulevard of Beaver Street to rehabilitate the wastewater laterals, as well as to install new maintenance holes. The contractor for this project is Atlantis Underground Services Inc., with project administration by Halton Region.

Due to the nature of the construction, there is the possibility of vibration from the work activities. Halton Region has retained a specialized inspection company, **Wristen's Home Specialties Inc. (WHS)**, to perform interior and exterior condition inspections of all buildings in the area prior to the start of construction. The inspectors will take photographs of the interior and exterior of buildings and structures, and provide written descriptions of their existing condition. The inspection typically takes about an hour to complete and will require someone to be at home to accompany the inspector. **There is no cost to residents or property owners for the inspection service.**

WHS will be sending you a letter over the next two weeks, with more information regarding how to schedule the inspection. 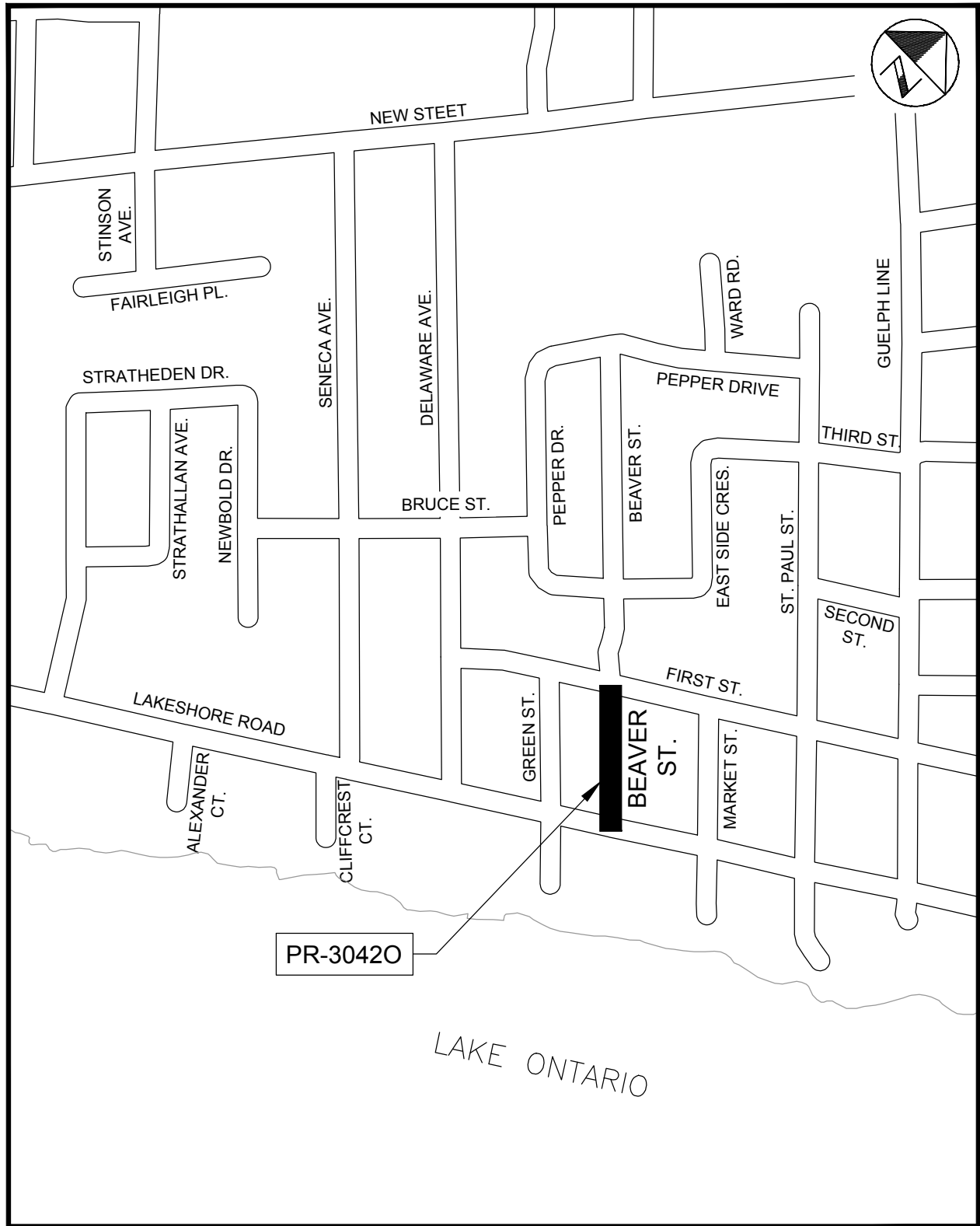
