	Avid Banihashemi of Burnside received a call from Fawn Sault on April 24, 2017, asking about the footprints of the project on the Credit River. Avid responded that the study is at very early stages and the potential options are not confirmed yet.
	Fawn noted that they want to be closely involved in all different stages of the EA study. Most particularly:
	 They want to have their representatives/monitors present at the natural studies surveys. They asked for a natural survey work plan to be sent to them as well. They want to have a meeting with the Region to clarify the potential footprints of the project, more specifically on the Credit River.
	Avid explained that there is paperwork that needs to be done including a liability waiver on the field.
	Sanjeev Oberoi of the Region received a call from Fawn Sault on April 28, 2017. She notified that if the Stage 1 archeological Study escalated to a Stage 2 Study, then they would like to be involved in the Study. She also requested to meet with the Region sometime in June to speak about this.
	Sanjeev informed her that he will initiate the discussion with his senior management regarding this and reminded her to send him the response form. She said she is drafting a letter for the Region and the request to meet with the Region will be included in that.

- Sanjeev Oberoi of the Region received an email from Fawn Sault and Karissa Johnson on June 23, 2017. The email noted that 'at this time', MNCFN has a low level of concern about the project. They asked that the Project Team immediately notify MNCFN if there are any changes to the project as they may impact MNCFN's interests and that MNCFN employs Field Liaison Representatives must be on location whenever any fieldwork for environmental and/or archaeological assessments is undertaken.
- Sanjeev Oberoi of the Region sent an email to the email address listed on the left on July 10, 2017, with a formal letter attached. The email noted that the Project Team looks forward to continued dialogue and consultation with MNCFN throughout the course of the Study.

However, if the archaeological assessment goes beyond a stage 1 desktop survey or the Project team otherwise becomes aware of information about potential impacts to Aboriginal or treaty rights, the Region is open to re-visiting the issue.

The email also noted that a couple of the suggested meeting dates are outlined in the attached letter. The email asked MNCFN to confirm their potential availability on either of the suggested dates or alternatively suggest a different date and time that may be suitable for MNCFN representatives.

Class EA Study. She asked about the status of the project, Sanjeev explained that the Region is currently in the process of getting ready to start the Natural Environment Review Study. She mentioned that HDI would like to put monitors out in the field also to do the Study.

- Sanjeev Oberoi of the Region received a call from Todd Williams (HDI Staff) on April 20, 2017. He said that he is calling regarding setting up HDI staff for the frog call survey work with Burnside. Sanjeev informed him that HDI has to sign a waiver document/agreement with the Region before their staff can go to the site for field work. Todd agreed with this approach and said that HDI has a standard template which he will send to Sanjeev. Sanjeev informed him that this document has to be reviewed by his supervisor and Manager along with the Region's legal team. He also told Todd that since the approval process for the waiver document cannot be done overnight. The Region will proceed with the Frog call survey work because this work cannot be delayed any further. Todd agreed with this and said that HDI needs to be kept in the loop for any future field work.

The Region's John Street Wastewater Pumping Station (WWPS) in Georgetown is nearing the end of its useful life and requires significant capital upgrades in order to maintain station in a state of good repair.

Accordingly, Halton Region has retained R.J. Burnside & Associates Limited (Burnside) to undertake a Municipal Class Environmental Assessment (EA) Study to consider a wide range of WWPS and/or collection system upgrade alternatives, in order to select the most appropriate station design concept that meets Halton Region's latest design standards. Alternative solutions may include construction of a new emergency over flow to the Credit River to reduce the risk of a sewer surcharge in the event of WWPS system failure and/or during peak wet weather events.

This Study is being carried out in accordance with the planning and design process for Schedule 'B' projects as outlined in the Municipal Engineers Association *Municipal Class Environmental Assessment* (October 2000, as amended in 2015), which is approved under the Ontario *Environmental Assessment Act.* The Study Area is shown in the attached Notice.

In order to initiate engagement, we are notifying your Indigenous community of the project (see enclosed notice) in hope that you can assist our Study project team in determining if your community may hold an interest in this project. Study

The Region's John Street Wastewater Pumping Station (WWPS) in Georgetown is nearing the end of its useful life and requires significant capital upgrades in order to maintain the station in a state of good repair. Accordingly, Halton Region initiated a Municipal Class Environmental Assessment (Class EA) Study that will consider a wide range of WWPS and/or collection system upgrade alternatives, in order to select the most appropriate station design concept that meets Halton Region's latest design standards, including provision for an emergency over flow to reduce the risk of a sewer surcharge in the event of WWPS system failure and/or during peak wet weather events. The impact of the WWPS upgrade alternatives on social, cultural, economic and natural environments will be evaluated and assessed during the Class EA Study.

The WWPS site location and approximate extent of the Study Area are shown on the map.

Process


This notice signals the commencement of the Class EA Study, which will define the problem, identify and evaluate alternative solutions, and determine a preferred solution in consultation with the Town of Halton Hills, regulatory agencies and the public. The Study is being carried out in accordance with the requirements of a Schedule B undertaking under the Municipal Class Environmental Assessment (October 2000, as amended 2007, 2011 & 2015), which is an approved process under the Ontario Environmental Assessment Act.

Consultation with stakeholders, such as the public and review agencies, is a key component of the Study process, and input will be sought throughout the Study. A Public Information Centre (PIC) is anticipated to be held in summer 2017. Details regarding the forthcoming PIC will be advertised as the Study progresses. Upon completion of the Study, a Project File will be prepared and placed on the public record for a minimum 30-day review period. The document will detail the planning and consultation processes and the preferred alternative.

Thank you for your May 1, 2017 correspondence. The purpose of this letter is to respond to your letter as well as your May 25 e-mail, and to provide additional information about the engagement process that Halton Region is undertaking as part of this Municipal Class EA Study process. This process includes consultation opportunities for stakeholders including the Haudenosaunee Confederacy Council of Chiefs (HCCC), or the Haudenosaunee Development Institute (HDI) on HCCC's behalf.

Consultation for this Study will comply with the mandatory guidelines developed by the Municipal Engineers Association (MEA) for First Nations and Aboriginal Peoples consultation as detailed in its Municipal Class Environmental Assessment document. Halton Region also recognizes and follows the Ministry of Environment and Climate Change "Areas of Interest" guidance protocol for Aboriginal consultation under the Ontario *Environmental Assessment Act*.

Halton Region is committed to the open flow of information and to ensuring that there are meaningful opportunities for HCCC/HDI to provide input during the Study. The project team notified HCCC/HDI of the Study Commencement. HCCC/HDI also will receive timely notification of the future Public Information Centre and the filing of the Study Project File Report during the public review period. Throughout the course of this Study, the project team will be available to discuss HCCC/HDI's questions or concerns regarding the project.

When the Project File Report is placed on the public record at the end of the Study, HCCC/HDI will also have full public access to the document. This Report will include all completed environmental field work and archaeological assessment undertaken within the Study area, including the associated findings and/or recommendations. Again, during the public review period, the project team is available to review this information with HCCC/HDI.

While Halton Region encourages HCCC/HDI to provide comments and input during the Study process as described above, it does not agree that HDI is entitled to determine an engagement model. At this juncture, the Region will not enter into the Environmental Monitoring Agreement you provided. The Region is open to re-visiting the issue of monitoring, however, if the archaeological assessment goes beyond a stage 1 desktop survey or the project team otherwise becomes aware of information about potential impacts.

Your letter references the Nanfan Treaty of 1701, the Treaty of Fort Stanwix of 1768, and the Board of Trade and Plantations understanding of Haudenosaunee territory in 1755. Based upon, among others things, the historical record, Halton Region does not accept the proposition that the Study lands are "owned" by the Haudenosaunee/Confederacy. Further, to the Region's knowledge, Six Nations/Confederacy/HDI has never asserted in a legally recognized way aboriginal title to the lands within Halton Region. This view was communicated by the Region to HDI and Mr. Detlor last summer.

Further to this point, neither the Crown, nor HCCC/HDI, has identified any potential impacts to Aboriginal or treaty rights arising from the Study. Any concerns about unjustified impairments arising from the Ontario *Environmental Assessment Act* itself are better directed to the Crown.

If HCCC/HDI would like to meet with the project team, it is available on June 15 or June 22, 2017. If HCCC intends to participate in the Study process through HDI, kindly provide the appropriate HCCC authorization to that effect prior to the meeting. This authorization should identify the HDI individual(s) who are authorized to provide comments and input on HCCC's behalf. Please note that all correspondence and engagement between the project team and HCCC/HDI will be documented in the Indigenous Communities Consultation Record. This Record will be incorporated into the final Study Project File.





<u>21st April, 2017</u>: Talked to Fawn Sault, on behalf the Region of Halton to follow up on a Notice Study Commencement sent out to the Ms. Fawn Sault, Consultation Manager, Mississaugas of the New Credit First Nation on March 22nd on John St. WWPS Class B EA and the attached form, and if the community got a chance to review and share their comments/concerns. Fawn requested that electronic versions be sent to her via email. The Region sent the electronic version on the letter and the form on the same day.

<u>24th April, 2017</u>: Avid Received a call from Fawn Sault early morning. Fawn asked about the footprints of the project on the Credit River. Avid responded that the study is at very early stages and the potential options are not confirmed yet. Fawn noted that they want to be closely involved in all different stages of the EA study. Most particularly:

- 1. They want to have their representatives/monitors present at the natural studies surveys. They asked for a natural survey work plan to be sent to them as well.
- 2. They want to have a meeting with the Region to clarify the potential footprints of the project, more specifically on the Credit River. Fawn wants that to happen around June.

She emphasized that they need this meeting since they are not public or stakeholder, but the rightholder, and therefore they want to be more closely involved at the early stages of the project before the PIC.

Avid explained that there is paperwork that needs to be done including a liability waiver on the field. Fawn noted that the paper work be referred to Meaghan Devries (MNCFN).

Avid also note that there is a general plan for the fieldwork, but since there are limitations for each survey (e.g. weather) there are ranges of dates for when they are going to happen. The next upcoming survey is the Bat Habitat Survey coming up on 28th April, 2017 and hopefully the paper work would be ready by the end of the week (28th) to make the MNCFN monitors' attendance possible.



We are the Mississaugas of the New Credit First Nation (MNCFN), the descendants of the Mississaugas of the River Credit. Our traditional territory extends from the Rouge River Valley in the east, across to the headwaters of the Thames River, down to Long Point on Lake Erie, and back along the shores of Lake Erie, the Niagara River, and Lake Ontario to the Rouge River Valley. It encompasses present-day London, Hamilton, and Toronto, as well as our communal lands. Our traditional territory has defined and sustained us as a First Nation for countless generations, and must continue to do so for all our generations to come.

Thank you for your notification on *the John Street Class EA Study on May 29, 2017*. The Mississaugas of the New Credit First Nation (MNCFN) has various treaty rights across its traditional territory, including the area contemplated by your project. For further information, please see our website, http://www.newcreditfirstnation.com/. MNCFN continues to exercise treaty rights which include, but are not limited to, rights to harvest, fish, trap and gather species of plants, animals and insects for any purpose including food, social, ceremonial, trade and exchange purposes. The MNCFN also has the right to use the water and resources from the rivers, creeks and lands across the MCNFN traditional territory.

At this time, MNCFN *does not* have a high level of concern regarding the proposed project and therefore, by way of this letter, approves the continuation of this project. However, MNCFN requests that you continue to notify us about the status of the project. In addition, we respectfully ask you to immediately notify us if there are any changes to the project as they may impact MNCFN's interests and that you please provide us with a copy of all associated

Additionally, MNCFN employs Field Liaison Representatives ("FLRs") to act as official representatives of the community and who are answerable to MNCFN Chief and Council through the Department of Consultation and Accommodation. The FLRs' mandate is to ensure that MNCFN's perspectives and priorities are considered in the field and to enable MNCFN to provide timely, relevant, and meaningful comment on the Project. Therefore, **it is MNCFN policy that FLRs are on location whenever any fieldwork for environmental and/or archaeological assessments are undertaken.** It is expected that the proponent will cover the costs of this FLR participation in the fieldwork. Please also provide the contact information of the person, or consultant, in charge of organizing this work so they may facilitate the participation of the MNCFN FLRs.

Nothing in this letter shall be construed as to affect the Aboriginal or Treaty rights and hence shall not limit any consultation and accommodation owed to MNCFN by the Crown or any proponent, as recognized by section 35 of the Constitution Act, 1982, of any other First Nation.

MNCFN reserves the right in relation to any development project or decision, to decide whether it supports a project and to: comment to regulators, participate in regulatory processes and hearings, seek intervener funding or status, or to challenge and seek remedies through the courts.

MNCFN expects all proponents to act according to the following best practices:

- Engage early in the planning process, before decisions are made
- Provide information in meaningful and understandable formats.
- Convey willingness to transparently describe the project and consider any MNCFN concerns.
- Recognize the significance of cultural activities and traditional practices of the MNCFN
- Demonstrate a respect for MNCFN knowledge and uses of land and resources.
- Understand the importance of youth and elders in First Nation communities.
- Act with honour, openness, transparency and respect.
- Be prepared to listen and allow time for meaningful discussion.

The purpose of this letter is to respond to your letter and to provide additional information about the engagement process that Halton Region is undertaking as part of this Municipal Class EA Study process. This process includes consultation opportunities for stakeholders including the Mississaugas of the New Credit First Nation (MNCFN).

Consultation for this Study will comply with the mandatory guidelines developed by the Municipal Engineers Association (MEA) for First Nations and Aboriginal Peoples consultation as detailed in its Municipal Class Environmental Assessment document. Halton Region also recognizes and follows the Ministry of Environment and Climate Change "Areas of Interest" guidance protocol for Aboriginal consultation under the Ontario *Environmental Assessment Act*.

Halton Region is committed to the open flow of information and to ensuring that there are meaningful opportunities for MNCFN to provide input during the Study. The project team notified MNCFN of the Study Commencement. MNCFN will also receive timely notification of the future Public Information Centre and the filing of the Study Project File Report during the public review period. Throughout the course of this Study, the project team will be available to discuss MNCFN's questions or concerns regarding the project.

When the Project File Report is placed on the public record at the end of the Study, MNCFN will also have full public access to the document. This Report will include all completed environmental field work and archaeological assessment undertaken within the Study area, including the associated findings and/or recommendations. Accordingly, at this juncture the Region does not support MNCFN Field Liaison Representatives' direct participation in the fieldwork. Please note that at this stage there is no archaeological assessment fieldwork being conducted. The Region's John Street Wastewater Pumping Station (WWPS) in Georgetown is nearing the end of its useful life and requires significant capital upgrades in order to maintain station in a state of good repair.

The impact of the WWPS upgrade alternatives on social, cultural, economic and natural environments will be evaluated and assessed during the Class EA Study.

The WWPS site location and approximate extent of the Study Area are shown on the map.

Process





The Region's John Street Wastewater Pumping Station (WWPS) in Georgetown is nearing the end of its useful life and requires significant capital upgrades in order to maintain the station in a state of good repair. Accordingly, Halton Region initiated a Municipal Class Environmental Assessment (Class EA) Study that will consider a wide range of WWPS and/or collection system upgrade alternatives, in order to select the most appropriate station design concept that meets Halton Region's latest design standards, including provision for an emergency over flow to reduce the risk of a sewer surcharge in the event of WWPS system failure and/or during peak wet weather events. The impact of the WWPS upgrade alternatives on social, cultural, economic and natural environments will be evaluated and assessed during the Class EA Study.

The WWPS site location and approximate extent of the Study Area are shown on the map.

Process


This notice signals the commencement of the Class EA Study, which will define the problem, identify and evaluate alternative solutions, and determine a preferred solution in consultation with the Town of Halton Hills, regulatory agencies and the public. The Study is being carried out in accordance with the requirements of a Schedule B undertaking under the *Municipal Class Environmental Assessment* (October 2000, as amended 2007, 2011 & 2015), which is an approved process under the *Ontario Environmental Assessment Act*.

Consultation with stakeholders, such as the public and review agencies, is a key component of the Study process, and input will be sought throughout the Study. A Public Information Centre (PIC) is anticipated to be held in summer 2017. Details regarding the forthcoming PIC will be advertised as the Study progresses. Upon completion of the Study, a Project File will be prepared and placed on the public record for a minimum 30-day review period. The document will detail the planning and consultation processes and the preferred alternative.


