Study

Halton Region has completed a Municipal Class Environmental Assessment (EA) Study to further improve public safety and address future travel demands on the Ninth Line (Regional Road 13) corridor from Highway 407 to 10 Side Road (Regional Road 10) in the Town of Halton Hills. The study has been conducted in compliance with Schedule C of the Municipal Class Environmental Assessment Process (October 2000, amended 2007 & 2011), which is approved under the Ontario Environmental Assessment Act.

Process

The Environmental Study Report (ESR) has been prepared to document the planning, public consultation and decision making process undertaken for this study. By this Notice, the ESR is being placed on the public record for a 30-day review period in accordance with the requirements of the Municipal Class EA. Subject to comments received as a result of this Notice and the receipt of necessary approvals, Halton Region intends to proceed with the detail design and widening of Ninth Line as documented in the ESR. 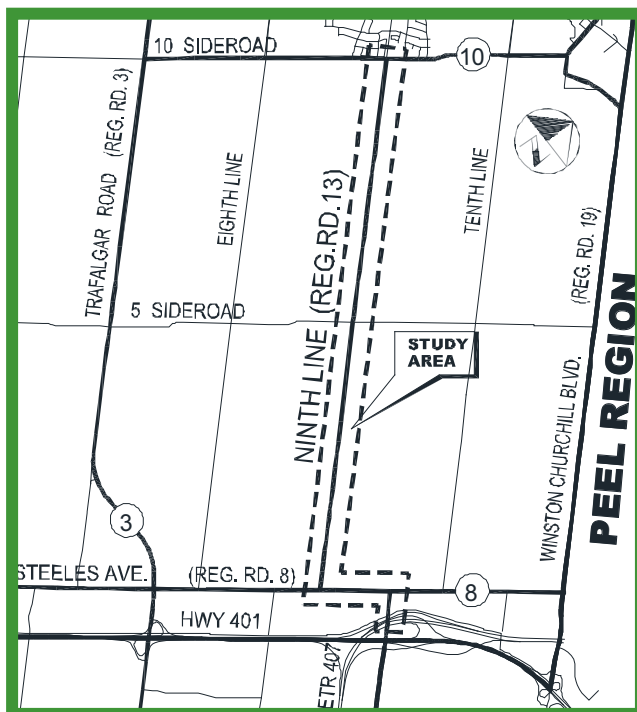
