



On behalf of Regional Council, I am pleased to present the results of the 2019 Employment Survey. Local businesses respond to our survey each year, allowing Halton Region to gather valuable information about employment in the area. The results also help us plan for the future by informing policy and decision-making, such as planning for infrastructure and service improvements to support our growing community.

The results of the 2019 Employment Survey show that over the past several years, the number of jobs in the region has increased and more businesses are choosing to call Halton home. Halton's Employment Areas support many of these jobs and businesses, and continue to play an important role in maintaining the economic competitiveness of our community.

Here are some more findings from the 2019 survey:

- More than 25 per cent of businesses had an increase in the number of jobs at their location.
- Over 46 per cent of local businesses and more than 50 per cent of jobs were located within Employment Areas identified in the Regional Official Plan.
- Over 60 per cent of companies were independently owned and operated.
- There was a 2.1 per cent annual increase in the number of jobs in Halton between 2015 and 2019—representing an additional 4,600 jobs each year.
- There was a 0.7 per cent annual growth in the number of businesses in Halton between 2015 and 2019—representing 91 more businesses each year.

Introduction

10th annual survey

In 2019, the Region conducted its 10th annual Employment Survey of businesses in Halton. Through the survey, the Region collects and updates information on business and employment across Halton. This includes data such as the number of employees, type of employment (full-time, part-time or temporary), industry sector and business space.

The results of this survey represent voluntary responses and input from businesses. These businesses have a physical location within Halton and are visible to the general public with business signage.

Report content

This report provides a summary of the 2019 Employment Survey results. In particular, the report:

- highlights the total number of businesses and jobs identified in 2019 as compared to the five-year trend from 2015 to 2019;
- presents additional information on businesses and jobs based on survey responses; and
- examines the geographic distribution of businesses and jobs across Halton, including within the Employment Areas identified in Halton's Regional Official Plan.



Total businesses identified

The 2019 Employment Survey identified a total of 13,650 businesses in Halton Region. Of the businesses identified, 88.5 per cent (12,086 businesses) were businesses identified in 2018 or earlier. In other words, these businesses have been operating in Halton since 2018 or earlier.

The other 11.5 per cent (1,564 businesses) were newly identified businesses in 2019. These represent businesses that were not identified during previous survey years.

Business ownership types

The majority of businesses in Halton were independently owned and operated¹, representing 62.9 per cent (8,075 businesses) of the total businesses identified in 2019.


Branch or subsidiary businesses² were the second most common, representing 21.3 per cent (2,734 businesses) of businesses identified in 2019.

Franchises³ represent 11.1 per cent (1,428 businesses) of businesses in Halton.


The remaining 4.8 per cent (607 businesses) of businesses in Halton were government or institutional organizations.

Changes between 2018 and 2019

In 2019, 1,167 businesses previously identified by the survey had closed since 2018. With the addition of 1,564 newly identified businesses in 2019, this resulted in a net increase of 397 more businesses between 2018 and 2019 in Halton.



Businesses: Five-year trend

Five-year business trend (2015-2019)

Between 2015 and 2019, the Employment Survey results show an overall increase of 2.9 per cent (391 businesses) in the total number of businesses identified over this five-year period. The results show an average annual increase of 0.7 per cent, or 91 additional businesses identified, each year over the last five years.

Five-year business trend by municipality (2015–2019)

By municipality, Milton had the highest annual rate of growth in the number of businesses identified, with an average increase of 1.1 per cent, followed by Oakville at one per cent. Halton Hills and Burlington saw an average increase of 0.8 per cent and 0.2 per cent each year, respectively.




Businesses: Geographic distribution

By Local Municipality

By municipality, Oakville had the highest share of the total identified businesses at 37.3 per cent (5,098 businesses), followed by Burlington with a share of 37.1 per cent (5,059 businesses). Together, Oakville and Burlington were home to about 75 per cent of Halton's total businesses identified in 2019.

Milton and Halton Hills had shares of 14.9 per cent (2,029 businesses) and 10.7 per cent (1,464 businesses), respectively.

Geographic distribution of k



The darker the colour, the higher the number of businesses in the area.

The 13,650 businesses identified in 2019 are located throughout Halton's settlement areas (urban areas and hamlets) and rural agricultural areas. As illustrated by the darker shades, there are visible concentrations of businesses (46 per cent of the total businesses identified, or 5,913 businesses) located within the Employment Areas identified in Halton's Regional Official Plan.



Total jobs identified

The 2019 Employment Survey identified a total of 241,423 jobs in Halton Region. The majority of jobs identified in 2019 were full-time positions,¹ representing 71.3 per cent (172,247 jobs) of total jobs. 24.1 per cent (58,087 jobs) of the jobs were part-time positions.²

The remaining 4.6 per cent (11,089 jobs) were identified as temporary positions.³



Jobs identified between 2018 and 2019

Within businesses that have operated since 2018 or earlier, an additional 12,216 jobs were identified in 2019. Within the businesses that were newly identified in 2019, 12,228 jobs were identified. Together, a total of 24,444 new jobs were identified in 2019

Due to businesses closures between 2018 and 2019, 11,915 jobs were lost. When accounting for both job losses and new jobs, the 2019 Employment Survey results show a net increase of 12,529 jobs identified in Halton since 2018.



Within businesses that have operated since 2018 or earlier, 28.9 per cent (3,264 businesses) reported an increase in the number of jobs at their location. 24.3 per cent (2,744 businesses) of the businesses reported a lower number of jobs at the location.

The remaining 46.8 per cent (5,291 businesses) indicated no change in the number of jobs at the location.



Five-year job trend (2015-2019)

Between 2015 and 2019, the survey results show an overall increase of 9.7 per cent (21,397 jobs) in the total number of jobs identified over this five-year period. The survey results show an average annual increase of 2.1 per cent, or about 4,600 additional jobs identified, each year over the last five years.




Total number of jobs reported by year

By municipality, Halton Hills and Milton had the highest annual rate of growth in the number of jobs identified, with an average increase of 4.5 per cent each year. Oakville and Burlington saw an average increase of 1.7 per cent and 1.2 per cent in additional jobs identified each year, respectively.



Milton and Halton Hills had shares of 36.3 per cent (87,595 jobs) and 9.6 per cent (23,216 jobs), respectively.









Businesses in this sector, as defined by the North American Industrial Classification System (NAICS), are primarily engaged in retailing merchandise, generally without transformation, and rendering services incidental to the sale of merchandise.




Manufacturing sub-sector by business and job

Manufacturing (top sector by job count) subsectors

In Halton Region, the manufacturing sector is the top sector by job count in 2019. Businesses in this sector, as defined by the North American Industrial Classification System (NAICS), are primarily engaged in the chemical, mechanical or physical transformation of materials or substances into new products. These products may be finished, in the sense that they are ready to be used or consumed, or semi-finished, in the sense of becoming a raw material for an establishment to use in further manufacturing.

The graph below provides a breakdown of the manufacturing sector by subsectors as defined in the NAICS:



^{1.} Miscellaneous Manufacturing include businesses that are not classified to any other subsector, primarily engaged in manufacturing activities. These establishments manufacture a diverse range of products, such as medical equipment and supplies, jewellery, sporting goods, toys and office supplies. 
Employment Area by geography

Under the Growth Plan for the Greater Golden Horseshoe (2019), the Province requires municipalities to designate Employment Areas within their official plans to protect and plan for employment uses over the long term.

Through the Regional Official Plan, Halton Region has identified Employment Areas to ensure sufficient lands are available to accommodate forecasted employment growth. These lands are also strategically identified and located based on their close proximity and access to existing major highway interchanges and rail yards.

Halton's Employment Areas represent about eight per cent of the Region's total land size.





Employment Areas by the numbers

Due to their strategic location, as well as Regional policies that protect and support economic activities, Halton's Employment Areas are home to a significant portion of the Region's economic activities.





Methodological notes

Annual survey

Halton Region conducts an annual employment survey of businesses across the region, which include for-profit establishments or non-profit/government organizations. These are businesses with a physical location within Halton and are visible to the general public with business signage.

The survey collects information on business types and employment activities to help the Region:

- · monitor economic and land use trends across the region;
- plan for future regional infrastructure and services; and
- assist in policy development and decision-making.

Participation in the survey is voluntary and the results presented in this report are based on the input of respondents.


2019 survey response rate

The 2019 Employment Survey identified a total of 13,650 businesses in Halton Region.

The response rate for the 2019 Employment Survey was as follows:

- 11,573 (84.8 per cent) businesses participated in 2019 and provided an up-to-date information;
- 1,478 (10.8 per cent) businesses were unavailable to participate (i.e. business was not open during the day, survey contact was not available, etc.);
- 599 (4.4 per cent) businesses declined to participate in 2019.

In cases where businesses were not available or declined to participate, information from the previous survey responses were used where applicable.



2019 Survey Data Collection Methodology

Between the months of May and September, a group of employment surveyors were deployed to visit all visible businesses across the Region. Prior to the deployment, the surveyors were provided with a comprehensive training on the survey methodology, process and protocols.

The survey incorporated a number of different methods to collect information from businesses using a custom developed tablet-based application or a printed survey questionnaire form. Surveyors were trained to use the most appropriate option.

The primary method of collecting data was through in-person interviews with follow-up interviews via telephone, email, or facsimile, as necessary. Businesses also had the option to respond by submitting an online survey form available on **halton.ca**. A description of each method is summarized below.

1. In-person interviews with the business

Surveyors visited and surveyed all visible businesses across Halton by primarily using a custom developed survey application installed on a secure electronic tablets. Information and responses received through the survey were electronically recorded on the secured tablets.

In cases where businesses were unavailable for survey at the time of the visit, the surveyors were trained to exercise options to potentially arrange an alternate time to revisit the business or provide alternate participation options, such as follow-up interviews via telephone, email or an online survey form available on **halton.ca**.

2. Follow-up interviews via telephone, email, facsimile, or responses received via regular mail.

In some cases, surveyors were trained to ask for the business contact information for a follow-up email via telephone or email during regular office hours or at a pre-arranged time.

Where appropriate, surveyors may have also left a printed survey questionnaire form with options for businesses to respond via regular mail, email or facsimile.

3. Online survey form via Halton Region's website

Businesses had the option of submitting a response through an online survey form available on **halton.ca** between May and September.

Data notes

The Employment Survey is a point-in-time survey based on voluntary participation. Accordingly, the data and results may not reflect the most current circumstances, particularly in certain industries experiencing rapid and frequent changes.

Halton Region does not warrant the completeness or accuracy of information contained in this report, and does not accept liability arising from the use or misuse of all or portions of such information. Caution should be used in interpreting the information in the report and making any conclusions.
