Regional Official Plan Amendment No. 38 (ROPA 38) to the Halton Region Official Plan was adopted by Regional Council on December 16, 2009. On November 24, 2011 the Minister of Municipal Affairs and Housing modified and approved ROPA 38. This decision was subsequently appealed in its entirety to the Ontario Municipal Board (OMB).
