RE: CN Intermodal Hub in Milton

Dear Minister Wilkinson,

I am writing to you today to applaud the values and vision expressed in the Speech from the Throne, and to urge you and your colleagues to bear them in mind as you complete your review of the CEAA panel's findings about CN's intermodal proposal.

The Speech from the Throne made it clear that your top priority is to protect the health of Canadians. Halton believes that how you respond to the CEAA panel report is a litmus test for what your vision means to our community, and to Canada.

As you know, the Federal Review Panel found that CN's project will cause significant adverse effects on human health. It would expose our residents to harmful toxic substances that are unsafe at any level. There can be no doubt: to approve this project would put Halton and its residents on the wrong track as it relates to their health.

The Federal Review Panel also made findings about the project's adverse effects on the environment. Your government is also committed to "building back better." The findings of the panel make it clear that CN's proposal is on the wrong track as it relates to your plans for a green recovery.
