On behalf of our Client, Nelson Aggregate Co., MHBC is pleased to provide you with the enclosed updated site plans for the Burlington Quarry and the Burlington Quarry Extension which are dated February, 2022.

MHBC previously submitted updated Burlington Quarry Extension Site Plans dated January 2022 to the agencies on January 19, 2022. Additionally, the updated Burlington Quarry Site Plans dated September 2021 were submitted to the agencies on November 4, 2021. The redlined revisions from these site plans have been removed and the redlined revisions incorporated in the enclosed drawings reflect all changes made since they were submitted to the agencies.

The following is a summary of the redlined revisions for the site plans:

- Both the Existing and Extension Site Plans have been updated to incorporate changes requested by OMAFRA. See attached letter from OMAFRA dated February 7, 2022 confirming they have no outstanding comments;
- The Extension Site Plans were updated to incorporate the change requested by MECP Species at Risk based on their review of the January 2022 Site Plans. See Section N Note C on Page 2 of 4 of the Burlington Quarry Extension Site Plans;
- The Existing Quarry Site Plans were also updated to show the revised licenced boundary and extraction limit for the Extension; and,
- The Extension Site Plans were updated to show an additional surveyed wetland located outside of the proposed licenced boundary for the West Extension as requested by NDMNRF.
