To whom it may concern,

Halton Region provided a Notice of Archaeological Screening Process (ASP) for the Premier Gateway Phase 2B Wastewater Servicing Strategy project on November 6, 2023. Due to changes in the project and the planning process, Halton Region has terminated the ASP for the referenced project. Instead, Halton Region has retained R.V. Anderson Associates Limited to undertake a Municipal Class Environmental Assessment (MCEA) study for the Halton Hills #4 Wastewater Pumping Station to service Phase 2B of the Premier Gateway Employment Area (PGEA) in the Town of Halton Hills. Phase 2B of the PGEA is located north of Steeles Avenue, between Eighth Line North and Winston Churchill Boulevard. Extending municipal water and wastewater services to Phase 2B of the PGEA is crucial to enable the development of this employment area.

The wastewater servicing strategy for Phase 2B of the PGEA was identified in the 2008 South Halton Water and Wastewater Master Plan Update and confirmed in the 2011 Sustainable Halton Water and Wastewater Master Plan. The strategy consists of a new wastewater pumping station close to the intersection of Steeles Avenue and Winston Churchill Boulevard and a combination of gravity sewers and forcemains along Steeles Avenue, connecting to Regional infrastructure at the west end of Phase 2B of the PGEA. The wastewater would then be conveyed to the Mid-Halton Wastewater Treatment Plant.




Figure 1. Halton Hills #4 Wastewater Pumping Station MCEA Study Area (green) and Previous Archaeological Screening Process Study Area (red).

This MCEA study will consider different site locations for the wastewater pumping station, focusing on feasibility, schedule deliverability, environmental and cultural impacts, land acquisition, coordination with ongoing and future projects and financial implications. This study is being carried out in accordance with Schedule B of the MCEA (October 2000, as amended 2007, 2011, 2015, and 2023), which is an approved process under the Ontario *Environmental Assessment Act*. The study area is shown in the attached Notice of Commencement. The study area for this MCEA study has changed with respect to the one identified for the ASP. This change is shown in Figure 1 at the end of this letter.

The purpose of this letter is to inform the Haudenosaunee Development Institute of the study, as well as to ask for assistance in determining if your Community may hold an interest in this project and if you would like to receive ongoing correspondence as the study progresses. We ask that you inform our project team of any preliminary questions, comments or concerns your Community has related to the MCEA study and the study area.

There will be opportunities for the public and interested parties to learn more about the project at future Public Information Centre (PIC) events. Separate from that process, the project team would like to extend an opportunity to the Haudenosaunee Development Institute to meet with the project team to learn more about the project, if desired. All comments and feedback from the Haudenosaunee Development Institute related to this study are welcome and will be considered throughout the MCEA study.

Upon completion of the MCEA Study, a Project File Report (PFR) will be prepared to document the MCEA Study process, including an inventory of environmental conditions, development and evaluation of

alternative solutions, potential environmental impacts and mitigation measures, and the consultation process. A Notice of Completion will be issued to indicate that the planning process is complete. The PFR will be made publicly available for review and comment for a minimum of 30 days.

#### **Archaeological Assessments**

In August 2023, LHC Heritage Planning & Archaeology Inc. conducted a Stage 1 Archaeological Assessment (herein referenced as "2023 Stage 1 AA") to support the ASP. The study area was a one-hectare parcel located within a larger property close to the intersection of Steeles Avenue and Winston Churchill Boulevard. The 2023 Stage 1 AA was completed on behalf of Halton Region to establish the archaeological significance of the proposed wastewater pumping station property and identify any potential archaeological resources (including those of Indigenous descent). In previous correspondence, it was indicated that Halton Region would proceed with a Stage 2 AA, as recommended in the 2023 Stage 1 AA.

After consultations with the Ministry of Citizenship and Multiculturalism (MCM), Halton Region was informed that the subject property was previously assessed in 2021 through a Stage 1 and 2 Archaeological Assessment conducted by The Archaeologist Inc. on behalf of the private landowner (herein referenced as "2021 Stage 1 & 2 AA"). The 2021 Stage 1 & 2 AA study area included the entire property beyond the proposed wastewater pumping station site. The 2021 Stage 1 and 2 AA was not yet entered into the registry when Halton Region conducted its 2023 Stage 1 AA, and therefore, it was not identified nor referenced.

Through correspondence with MCM staff, Halton Region was informed that the 2021 Stage 1 & 2 AA was entered into the registry, and, as such, MCM instructed Halton Region to update the 2023 Stage 1 AA accordingly. Based on the newly available documentation, the study area for the present MCEA study does not retain archaeological potential; therefore, a Stage 2 AA is no longer required.

The Region's subconsultant is revising the 2023 Stage 1 AA to include the new study area and to reference the 2021 Stage 1 & 2 AA. A draft copy of the revised 2023 Stage 1 AA can be provided for your review once it is completed. Halton Region welcomes your input before the revised 2023 Stage 1 AA is finalized and filed with MCM.



To whom it may concern,

Halton Region provided a Notice of Archaeological Screening Process (ASP) for the Premier Gateway Phase 2B Wastewater Servicing Strategy project on November 6, 2023. Due to changes in the project and the planning process, Halton Region has terminated the ASP for the referenced project. Instead, Halton Region has retained R.V. Anderson Associates Limited to undertake a Municipal Class Environmental Assessment (MCEA) study for the Halton Hills #4 Wastewater Pumping Station to service Phase 2B of the Premier Gateway Employment Area (PGEA) in the Town of Halton Hills. Phase 2B of the PGEA is located north of Steeles Avenue, between Eighth Line North and Winston Churchill Boulevard. Extending municipal water and wastewater services to Phase 2B of the PGEA is crucial to enable the development of this employment area.

The wastewater servicing strategy for Phase 2B of the PGEA was identified in the 2008 South Halton Water and Wastewater Master Plan Update and confirmed in the 2011 Sustainable Halton Water and Wastewater Master Plan. The strategy consists of a new wastewater pumping station close to the intersection of Steeles Avenue and Winston Churchill Boulevard and a combination of gravity sewers and forcemains along Steeles Avenue, connecting to Regional infrastructure at the west end of Phase 2B of the PGEA. The wastewater would then be conveyed to the Mid-Halton Wastewater Treatment Plant.




Figure 1. Halton Hills #4 Wastewater Pumping Station MCEA Study Area (green) and Previous Archaeological Screening Process Study Area (red).

This MCEA study will consider different site locations for the wastewater pumping station, focusing on feasibility, schedule deliverability, environmental and cultural impacts, land acquisition, coordination with ongoing and future projects and financial implications. This study is being carried out in accordance with Schedule B of the MCEA (October 2000, as amended 2007, 2011, 2015, and 2023), which is an approved process under the Ontario *Environmental Assessment Act*. The study area is shown in the attached Notice of Commencement. The study area for this MCEA study has changed with respect to the one identified for the ASP. This change is shown in Figure 1 at the end of this letter.

The purpose of this letter is to inform the Huron-Wendat Nation of the study, as well as to ask for assistance in determining if your Community may hold an interest in this project and if you would like to receive ongoing correspondence as the study progresses. We ask that you inform our project team of any preliminary questions, comments or concerns your Community has related to the MCEA study and the study area.

There will be opportunities for the public and interested parties to learn more about the project at future Public Information Centre (PIC) events. Separate from that process, the project team would like to extend an opportunity to the Huron-Wendat Nation to meet with the project team to learn more about the project, if desired. All comments and feedback from the Huron-Wendat Nation related to this study are welcome and will be considered throughout the MCEA study.

Upon completion of the MCEA Study, a Project File Report (PFR) will be prepared to document the MCEA Study process, including an inventory of environmental conditions, development and evaluation of alternative solutions, potential environmental impacts and mitigation measures, and the consultation

process. A Notice of Completion will be issued to indicate that the planning process is complete. The PFR will be made publicly available for review and comment for a minimum of 30 days.

### **Archaeological Assessments**

In August 2023, LHC Heritage Planning & Archaeology Inc. conducted a Stage 1 Archaeological Assessment (herein referenced as "2023 Stage 1 AA") to support the ASP. The study area was a one-hectare parcel located within a larger property close to the intersection of Steeles Avenue and Winston Churchill Boulevard. The 2023 Stage 1 AA was completed on behalf of Halton Region to establish the archaeological significance of the proposed wastewater pumping station property and identify any potential archaeological resources (including those of Indigenous descent). In previous correspondence, it was indicated that Halton Region would proceed with a Stage 2 AA, as recommended in the 2023 Stage 1 AA.

After consultations with the Ministry of Citizenship and Multiculturalism (MCM), Halton Region was informed that the subject property was previously assessed in 2021 through a Stage 1 and 2 Archaeological Assessment conducted by The Archaeologist Inc. on behalf of the private landowner (herein referenced as "2021 Stage 1 & 2 AA"). The 2021 Stage 1 &2 AA study area included the entire property beyond the proposed wastewater pumping station site. The 2021 Stage 1 and 2 AA was not yet entered into the registry when Halton Region conducted its 2023 Stage 1 AA, and therefore, it was not identified nor referenced.

Through correspondence with MCM staff, Halton Region was informed that the 2021 Stage 1 & 2 AA was entered into the registry, and, as such, MCM instructed Halton Region to update the 2023 Stage 1 AA accordingly. Based on the newly available documentation, the study area for the present MCEA study does not retain archaeological potential; therefore, a Stage 2 AA is no longer required.

The Region's subconsultant is revising the 2023 Stage 1 AA to include the new study area and to reference the 2021 Stage 1 & 2 AA. A draft copy of the revised 2023 Stage 1 AA can be provided for your review once it is completed. Halton Region welcomes your input before the revised 2023 Stage 1 AA is finalized and filed with MCM.

#### Annex 1 - Specific comments on the consultation

Some elements of the historical context would benefit from further elaboration. On page 8, it is written: "The Huron/Wyandot who, by the mid-17<sup>th</sup> century, had occupied areas around Lake Simcoe and along the south end of Georgian Bay, were dispersed by the Iroquois from south of Lake Ontario." The phrasing is not clear and could suggest that the Wendat were dispersed from the south of Lake Ontario, whereas this passage is meant to indicate that the Iroquois came from the south of Lake Ontario.

Later, it is written: "The Attawandaron (Neutral), at the west end of Lake Ontario, were similarly displaced by 1650 and the St. Lawrence Iroquois, encountered by Cartier at Hochelaga (Montreal), had completely disappeared by the time of Champlain's arrival to the region at the beginning of the 17th century." Information on the St. Lawrence Iroquoians could be more detailed in the report, especially considering the growing amount of evidence that they were linked to communities in Ontario. There are also plenty of theories regarding their disappearance from the St. Lawrence Valley. A discussion on this topic would enrich the report.

On page 13, it is written: "Between 1649 and 1655, the Haudenosaunee Confederacy waged warfare on the Huron, Petun, and Attiwandaron, pushing them out of their villages and the general area (Mississaugas of the Credit First Nation [MCFN2] 2018)." This section could provide more details on the event and be supported by sources external to a specific Nation.

Finally, we would like to investigate further on the recommendations of the report. Considering that the *draft revised Stage 1* bases its conclusion on *The Archaeologists Inc. 2021 Stage 1-2 assessment*, we would like to review this report. This verification is especially relevant given that the *draft revised Stage 1* conclusion is said to be inferred from a relation that is not explicit in the *2021 Stage 1-2* report.



Halton Region provided a Notice of Archaeological Screening Process (ASP) for the Premier Gateway Phase 2B Wastewater Servicing Strategy project on November 6, 2023. Due to changes in the project and the planning process, Halton Region has terminated the ASP for the referenced project. Instead, Halton Region has retained R.V. Anderson Associates Limited to undertake a Municipal Class Environmental Assessment (MCEA) study for the Halton Hills #4 Wastewater Pumping Station to service Phase 2B of the Premier Gateway Employment Area (PGEA) in the Town of Halton Hills. Phase 2B of the PGEA is located north of Steeles Avenue, between Eighth Line North and Winston Churchill Boulevard. Extending municipal water and wastewater services to Phase 2B of the PGEA is crucial to enable the development of this employment area.

The wastewater servicing strategy for Phase 2B of the PGEA was identified in the 2008 South Halton Water and Wastewater Master Plan Update and confirmed in the 2011 Sustainable Halton Water and Wastewater Master Plan. The strategy consists of a new wastewater pumping station close to the intersection of Steeles Avenue and Winston Churchill Boulevard and a combination of gravity sewers and forcemains along Steeles Avenue, connecting to Regional infrastructure at the west end of Phase 2B of the PGEA. The wastewater would then be conveyed to the Mid-Halton Wastewater Treatment Plant.

This MCEA study will consider different site locations for the wastewater pumping station, focusing on feasibility, schedule deliverability, environmental and cultural impacts, land acquisition, coordination with ongoing and future projects and financial implications. This study is being carried out in accordance with Schedule B of the MCEA (October 2000, as amended 2007, 2011, 2015, and 2023), which is an approved process under the Ontario *Environmental Assessment Act*. Halton Region provided a Notice of Archaeological Screening Process (ASP) for the Premier Gateway Phase 2B Wastewater Servicing Strategy project on November 6, 2023. Due to changes in the project and the planning process, Halton Region has terminated the ASP for the referenced project. Instead, Halton Region has retained R.V. Anderson Associates Limited to undertake a Municipal Class Environmental Assessment (MCEA) study for the Halton Hills #4 Wastewater Pumping Station to service Phase 2B of the Premier Gateway Employment Area (PGEA) in the Town of Halton Hills. Phase 2B of the PGEA is located north of Steeles Avenue, between Eighth Line North and Winston Churchill Boulevard. Extending municipal water and wastewater services to Phase 2B of the PGEA is crucial to enable the development of this employment area.

The wastewater servicing strategy for Phase 2B of the PGEA was identified in the 2008 South Halton Water and Wastewater Master Plan Update and confirmed in the 2011 Sustainable Halton Water and Wastewater Master Plan. The strategy consists of a new wastewater pumping station close to the intersection of Steeles Avenue and Winston Churchill Boulevard and a combination of gravity sewers and forcemains along Steeles Avenue, connecting to Regional infrastructure at the west end of Phase 2B of the PGEA. The wastewater would then be conveyed to the Mid-Halton Wastewater Treatment Plant.

This MCEA study will consider different site locations for the wastewater pumping station, focusing on feasibility, schedule deliverability, environmental and cultural impacts, land acquisition, coordination with ongoing and future projects and financial implications. This study is being carried out in accordance with Schedule B of the MCEA (October 2000, as amended 2007, 2011, 2015, and 2023), which is an approved process under the Ontario *Environmental Assessment Act*. The study area is shown in the attached Notice of Commencement. The study area for this MCEA study has changed with respect to the one identified for the ASP. This change is shown in Figure 1 at the end of this letter.

The purpose of this letter is to inform the Six Nations of the Grand River of the study, as well as to ask for assistance in determining if your Community may hold an interest in this project and if you would like to receive ongoing correspondence as the study progresses. We ask that you inform our project team of any preliminary questions, comments or concerns your Community has related to the MCEA study and the study area.

There will be opportunities for the public and interested parties to learn more about the project at future Public Information Centre (PIC) events. Separate from that process, the project team would like to extend an opportunity to the Six Nations of the Grand River to meet with the project team to learn more about the project, if desired. All comments and feedback from the Six Nations of the Grand River related to this study are welcome and will be considered throughout the MCEA study.

Upon completion of the MCEA Study, a Project File Report (PFR) will be prepared to document the MCEA Study process, including an inventory of environmental conditions, development and evaluation of alternative solutions, potential environmental impacts and mitigation measures, and the consultation process. A Notice of Completion will be issued to indicate that the planning process is complete. The PFR will be made publicly available for review and comment for a minimum of 30 days.

#### **Archaeological Assessments**

In August 2023, LHC Heritage Planning & Archaeology Inc. conducted a Stage 1 Archaeological Assessment (herein referenced as "2023 Stage 1 AA") to support the ASP. The study area was a one-hectare parcel located within a larger property close to the intersection of Steeles Avenue and Winston Churchill Boulevard. The 2023 Stage 1 AA was completed on behalf of Halton Region to establish the archaeological significance of the proposed wastewater pumping station property and identify any potential archaeological resources (including those of Indigenous descent). In previous correspondence, it was indicated that Halton Region would proceed with a Stage 2 AA, as recommended in the 2023 Stage 1 AA.

After consultations with the Ministry of Citizenship and Multiculturalism (MCM), Halton Region was informed that the subject property was previously assessed in 2021 through a Stage 1 and 2 Archaeological Assessment conducted by The Archaeologist Inc. on behalf of the private landowner (herein referenced as "2021 Stage 1 & 2 AA"). The 2021 Stage 1 &2 AA study area included the entire property beyond the proposed wastewater pumping station site. The 2021 Stage 1 and 2 AA was not yet entered into the registry when Halton Region conducted its 2023 Stage 1 AA, and therefore, it was not identified nor referenced.

Through correspondence with MCM staff, Halton Region was informed that the 2021 Stage 1 & 2 AA was entered into the registry, and, as such, MCM instructed Halton Region to update the 2023 Stage 1 AA accordingly. Based on the newly available documentation, the study area for the present MCEA study does not retain archaeological potential; therefore, a Stage 2 AA is no longer required.

The Region's subconsultant is revising the 2023 Stage 1 AA to include the new study area and to reference the 2021 Stage 1 & 2 AA. A draft copy of the revised 2023 Stage 1 AA can be provided for your review once it is completed. Halton Region welcomes your input before the revised 2023 Stage 1 AA is finalized and filed with MCM.
